Schedule A is accurate with regards to the total amount of donations received. However, it is incomplete with regards to the amounts, names, and addresses of donors. We received a significant number of contributions via Paypal. Soon after the election we closed the Paypal account to receipts without realizing we could not go back in later to download specific donor information. The Paypal funds were periodically transferred to our checking account at CountryBank in accumulated amounts without any individual transaction history. We are attempting to rectify this problem but we have not been successful as of this filing date. We will file a revised Schedule A when and if we can retrieve the relevant information.
