In the name of the Commonwealth of Massachusetts, you are hereby required to notify and warn the inhabitants of the Town of Hardwick, qualified to vote in town affairs, to meet at the Hardwick Elementary School, 76 Schoolhouse Drive, Gilbertville, Massachusetts on Saturday, June 17th, 2017 at 9:00 A.M., then and there to act on the following articles:

**The Moderator read the call of the beginning and the ending of this warrant and declared the warrant has been called and posted according to town by-laws.**

**Motion made and seconded and voted unanimously to dispense with the reading of the articles and to take them up in their order as they appear on the warrant.**

**Article 1.** To see if the Town will vote to transfer a sum of money from available funds in the treasury to meet overdrawn and unprovided for accounts in the current Fiscal Year 2017, pursuant to the requirements of Massachusetts General Laws Chapter 44, section 64; or to take any other action relative thereto.
